UNMETERED WELL OR UNITS WITHOUT A FUNCTIONING WATER METER:

Commercial and Industrial Sewer Gallorage Charge will be estimated using CT Public Health Code, section 19-13B-103, Table 4 with NMSC multiplier of (0.6). Residential Sewer Gallorage Charge will be 34,750 gallons for each bedroom.
